

Planning District 1a - CBD and Warehouse District and Planning District 1b - Vieux Carre Community Organizations by Service Area

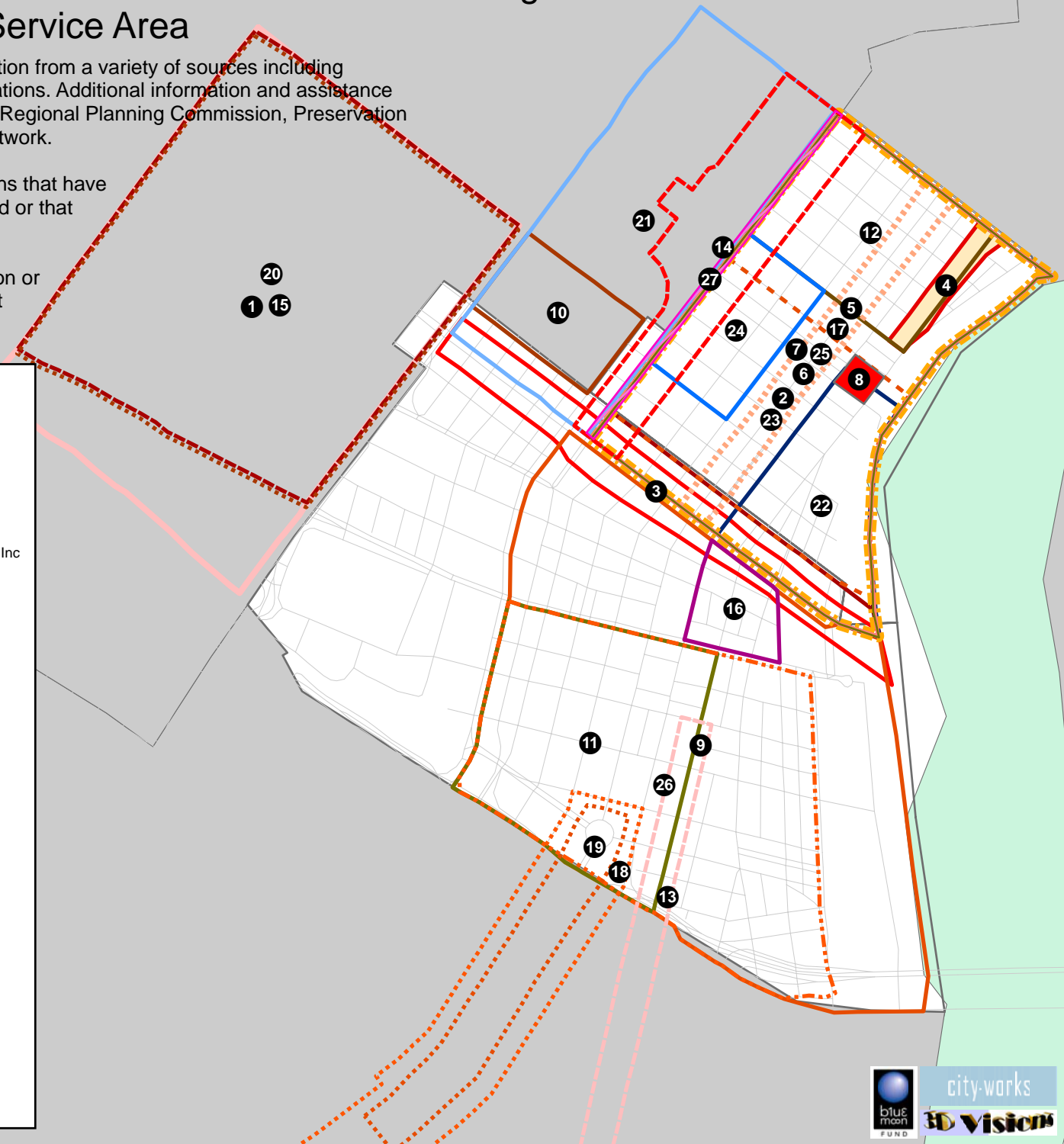
